WHEREAS, the Arts Commission desiree to promote and further diversity, equity and inclusion of all of Ypsilanti in the arts; and

WHEREAS, the Arts Commission desires to collect information from the community about the arts to inform the Commission in its role with the City, share this information with local, state and national arts organizations and provide insight on the current state of the arts in Ypsilanti.

WHEREAS, the City of Ypsilanti City Council approved the Community and Artists Survey Ypsilanti Art Commission Action Plan, and the Request for Qualifications for the Community and Artists Survey Outreach Consultant in October of 2021; and

WHEREAS, the grant of \$4,000 from the Tremaine Foundation for the implementation of this survey was received by the City of Ypsilanti on November 22, 2022; and

WHEREAS, the Arts Commission identified questions on the approved survey that are no longer relevant or valuable due to the time lapsed between approval and receiving of the funds; and

WHEREAS, the Arts Commission has reviewed updated the Community and Artists Survey questions, included translation services Artists Survey Ypsilanti Art Commission Action Plan; and

WHEREAS, the Arts Commission wishes to recommend implementation of the Community and Artists Survey Ypsilanti Art Commission Action Plan, and the Request for Qualifications for the Community and Artists Survey Outreach Consultant as amended; and

NOW THEREFORE BE IT RESOLVED, by the Arts Commission of the City of Ypsilanti, that this resolution is provided to the City Manager and City Council for recommendation.
