WHEREAS, consolidating these precincts will result in cost savings and will improve efficiency in conducting the election;

NOW THEREFORE BE IT RESOLVED THAT the Ypsilanti Election Commission approves the consolidation of precincts for the May 3, 2022 Special Election as follows:

Ward 2 Precincts 1, 2, and 3 Estabrook Elementary School 1555 W. Cross St.

Ward 2 Precinct 4 EMU Honors College 501 W. Forest St.

& Ward 3 Precinct 1

Ward 3 Precinct 2 & 3 Ypsilanti International Elementary School
