

## **Residential Lot Application**

Thank you for your interest in tax reverted property owned by the City of Ypsilanti (City). The mission of the City is to return tax reverted properties to productive and economically viable use. This application process will assist individuals who are interested in purchasing or otherwise acquiring properties owned by the City.

## **The Application Process:**

1. Submit a completed application to the City at:

- 2. Upon receipt of your completed application, a \$50.00 application fee, and the required documentation, the City will evaluate your application.
- 3. The applicant will be notified if the application is approved or denied. If approved, the applicant will be sent a property transfer affidavit as well as an invoice for \$1,450 (\$1,000 for property and \$500 for closing costs minus the application fee). Please submit your application with a \$50.00 check/money order. The city will reach out to the applicant to make arrangements for final payment if the application is approved.

## **Residential Lot Application**

Properties included in the Program must meet the following criteria:

- (a) Applicant must be willing to have homestead status on the property if a house is built.
- (b) Applicant shall be current and have a record of staying current on all property taxes (if applicable).
- (c) Applicant shall have no outstanding tickets or property violations within the City of Ypsilanti or a history of property violations.

The City in its sole discretion may choose to include or not include any given parcel of property in the residential program.
