Chapter 94

An alley is a public right-of-way, much like a street or sidewalk. It is a secondary means of access to adjoining properties, meant for occasional or light use. It is not intended to function as a road or a primary means of access. These alleys are usually dedicated when an area is platted initially. Due to changes in traffic or other circumstances, owners of adjoining property may wish for the alleys to be closed or vacated.

Alley Closure: closes the alley to vehicle through traffic with the placement of a barrier, usually located about halfway through the alley. The alley remains open to pedestrians and bicyclists, and can be used by adjoining property owners for access. Alley remains the property of the city and is the City's responsibility to maintain.

Alley or Street Vacation: When an alley is vacated, the City gives up ownership of the alley to the neighbors. Title to the right of way is vested according to the provisions of the Land Division Act, State Act 288 of 1967. Once title is vested, it becomes the responsibility of the neighbors to maintain and/or obstruct, as they so choose. If utilities are located in the alley (electric, gas, telephone, other), the City will require that easements remain in place for the respective authorities to access and maintain. Once the City has passed an ordinance vacating its interest in the alley, the applicant must pursue the matter in district court for a full vacation.

Applying for an Alley Closure or Vacation

Anyone may petition to close or vacate an alley using the attached application. Generally, petitions must answer a list of criteria provided in Chapter 94 of the Code of Ordinances. Those criteria include:

- Whether the closing will create an undue burden on traffic.
- Whether the closing is necessary to address safety concerns.
- The wishes and desires of the majority of the neighborhood.
- The present and future interests of the City.

Review Process and Timeline

Once your application is received, staff will schedule a public hearing. If your application is complete and received by 4:00 p.m. on the third Wednesday of the month, it will be heard in front of Planning Commission at their regular meeting at 7:00 p.m. on the third Wednesday of the following month. During the intervening time, staff will review the application, notify neighbors within 300' by first-class mail, and place a notice in the Washtenaw Legal News.

At their meeting, Planning Commission will hold a public meeting, where the public are invited to address them about the proposed vacation or closure. They also hear a staff report about the vacation or closure's appropriateness, and invite the applicant to speak. With the information they gather at this meeting, they make a recommendation to City Council.

City Council will generally hear the request and the Planning Commission recommendation at their regularly scheduled meeting on the second Tuesday of the following month.
